

**BOROUGH OF NORTH EAST
ORDINANCE NO. 888**

**AN ORDINANCE AMENDING ORDINANCE NO. 561
AND ANY OTHER ORDINANCE PROVIDING RULES AND REGULATIONS
FOR THE PARKING OF MOTOR VEHICLES UPON THE STREETS
OF THE BOROUGH OF NORTH EAST**

PREAMBLE

WHEREAS, on March 4, 1969, the Borough of North East enacted Ordinance No. 561 which is an Ordinance providing rules and regulations for the parking of motor vehicles upon the streets of the Borough of North East, and;

WHEREAS, the Borough of North East may have amended Ordinance No. 561 and/or may have enacted other Ordinances providing rules and regulations for the parking of motor vehicles upon the streets of the Borough of North East, and;

WHEREAS, the Borough Council of the Borough of North East desires to amend Sections 4(b) and 4(c) of Ordinance No. 561 and any other Ordinances governing parking and motor vehicles upon the streets of the Borough of North East that contain language addressing approved storage garages and the charges associated with towing for impounded vehicles as provided in this Ordinance, and;

WHEREAS, the Borough Council of the Borough of North East desires to amend Sections 6 of Ordinance No. 561 and any other Ordinances establishing penalties or fines for violating rules and regulations for the parking of motor vehicles upon the streets of the Borough of North East.

THEREFORE, BE IT ORDAINED AND ENACTED, by the corporate authorities of the Borough of North East, Erie County, Pennsylvania, and it is hereby enacted by the Authority of the same that Ordinance No. 561 shall be amended as follows:

Section 1. Sections 4(b) and (c) of Ordinance No. 561 shall be amended to read as follows:

(b) Impounded vehicles shall be towed by such towing companies and stored at such locations as are designated by the Chief of Police.

(c) The towing and storage charges shall be those charges as determined by the towing companies and the storage locations selected by the Chief of Police.

Section 2. Section 6 of Ordinance No. 561 shall be amended to read as follows:


Section 6 – Any person who shall violate any of the provisions of this Ordinance or the regulations as prescribed by the Streets Commissioner under authority hereof, shall upon conviction thereof, be sentenced to pay a fine of not less than \$15.00 and not more than \$50.00, and costs of prosecution, and in default of payment of such fine and costs, to imprisonment in the County jail for not more than five (5) days.

Section 3. All previous Ordinances of the Borough of North East pertaining to approved storage garages, charges associated with towing for impounded vehicles, and penalties for violation of parking regulations are hereby repealed.


Section 4. The within Ordinance shall take effect on July 5, 2016


