#### North East Fire Department – Act 172 Fire Fighter Tax Credit Program

N. Anderson asked J. Di'Orazio, Fire Chief, how many volunteer firefighters reside in the North East Borough who would be affected by the proposed tax credit program. J. Di'Orazio stated that approximately 10-15 firefighters live within the Borough, but that approximately 10 are currently property owners who would benefit from the program. B. Beardsley asked if the credit was automatically available. J. Di'Orazio stated that firefighters apply annually, submitting rosters of participation in drills, fundraising, call answering, etc. He stated that they currently receive a 20% tax credit, but that they are requesting a 100% tax credit. H. Jones motioned to approve the North East Fire Department – Act 172 Fire Fighter Tax Credit Program as presented. R. McGregor seconded. After a roll call vote, the motion carried unanimously.
