## **PUBLIC HEARING:**

#### Ordinance No. 932 – Traffic Regulations and Stop Intersection

Borough Council President A. Belson called the Public Hearing to order at 6:00 p.m.

S. Hubbard, 47 Grahamville Street, asked for clarification on the additional stop signs, as well as the direction of the one-way traffic on Wall Street. P. Gehrlein stated that the proposed ordinance would create a four-way stop intersection at Park and Gibson Streets, and that the traffic on Wall Street would be one-way going west.

K. Smithers, 13 Clinton Street, stated her concerns for making South Pearl Street one-way from Clinton to Wall Streets, stating that it would negatively impact her business and the surrounding businesses. She stated that commercial truck drivers would have difficulty navigating the area and that it would unnecessarily increase

traffic through a residential area. She suggested adding speed bumps and a stop sign at Pearl Street instead of changing the traffic direction.

H. Kelly, North East Athletic Club, stated her agreement with K. Smithers, that she did not agree with the proposed one-way traffic on South Pearl Street and Wall Street.

There were no other public comments. The public hearing ended at 6:10 p.m.

#### **ANNOUNCEMENTS:**

- N. Anderson thanked the Streets Department, specifically Robin Goodenow, for the beautiful work on the archways in Gibson Park.
- A. Belson stated that there is a state law that prohibits grass being blown into the street when mowing.
- A. Belson reminded the community to carefully watch the crosswalks and intersections, especially as kids will be out of school for the summer months.
- A. Belson stated that there was a meeting today with GECAC regarding the use of the building at 50 East Main Street. She stated that they are moving forward with the process of creating an advisory board and developing a framework for how the building will be used in the future.

#### **PUBLIC COMMENTS:**

- S. Burniston, 11751 Peabody Road, stated that he and his brother enjoy fishing at Grahamville Reservoir and are upset to see adults recently leaving trash in the area. He recommended making the area open by permission only or making it catch-and-release only.
- W. Burniston, 11751 Peabody Road, stated that he also enjoys fishing at Grahamville Reservoir and supports his brother's comments to make the Reservoir by permission only or catch-and-release fishing only.
- S. Hubbard, 47 Grahamville Street, stated that the Skunk and Goat's advertisement for the Cornhole League includes drinks, asking for clarification of their permitted consumption in the park. A. Belson stated that it was not part of their requested use of the park.
- D. Meehl, 61 East Division Street, asked for an update regarding her neighbor's code enforcement case.
- P. Gehrlein stated that there has been official action through the District Justice and that steps are moving forward in the case.
- R. Adkins, 80 Wellington Street, asked for an update on several houses in disrepair on Wellinton Street.
- P. Gehrlein stated that there are several on-going code enforcement cases involving the District Justice, but that there are several steps that must take place.
- J. Schneider, 64 Eaton Drive, asked for an update regarding his neighbor's code enforcement case. P. Gehrlein informed him of an upcoming hearing at the District Justice.
- K. Smithers, 13 Clinton Street, thanked North East in Bloom for the beautiful work around town.

| S. Hubbard, 47 Grahamville Street, asked if there was an ordinance in place that set a time limit for clean-up of a house damaged by fire. P. Gehrlein stated that fire is an overall contributor to structural damage but that no time frame is set. He stated that insurance often sets time tables for action regarding claims. |   |  |
