



## PROGRAM GUIDELINES

- Funding available for exterior home improvement projects that enhance the curb appeal and increase the overall property value
- The Building Blocks program will provide direct matching funding for qualifying projects up to \$5,000 maximum.
- Funding is limited to program participants residing within the Borough of North East's boundaries.
- The program funds require that an applicant is the owner of the subject property and it is their primary residence.
- Program funds may be used to cover the costs of home improvement materials, contractor costs, landscaper costs and hardscape or landscape materials and plantings.
- Program funds may **NOT** be used to pay for sweat equity, in-kind services, existing or ongoing payments to a mortgage or line of credit, non-insured contractors/ professional services, or expenses incurred prior to application date.
- Projects utilizing the Building Blocks funding must be completed within ninety (90) days of contract signing.
- Additional time may be added to contracts for extenuating circumstances associated with the availability of services, scheduling and/or weather related delays.







- Borough representatives will track project progress throughout project timeline. Upon project completion and once matching funds have been verified and noted as paid in full, a check for matching funds will be issued either to the homeowner or contractor directly.
- Program participants must be willing to participate in program assessment and analysis to measure the program's effectiveness and impact. Additionally, program participants must display a program sign in their front yard during and immediately after program participation.
