# Nanci Haibach – North East History Museum Proposal

N. Haibach gave a brief presentation of the history of the North East Laundry Basket and the ball sign that was recently removed. She stated that the ball sign used to light up and revolve, and that it is a historical artifact that should be displayed in town. She stated that she has been in contact with Harbor Creek Township, who received the ball from the laundromat, and that they are willing to return the ball to the North East Historical Society. N. Haibach stated that the Historical Society would like to restore the ball and display it as a historical tourism attraction in town.

## Sherry Reed, 1700 N Pearl St – Eaton Reservoir Restroom Petition

S. Reed stated that she is a frequent visitor to Eaton Reservoir and expressed her frustration with the lack of restroom facilities on the east side of the property. She presented a petition asking for restroom facilities to be placed on the east side of the reservoir for visitors to use. T. Simmer stated that there is a grant in-process that will be used to build a restroom facility on the east side of the reservoir. He also stated that the Game Commission currently supplies Eaton Reservoir with a portable restroom on the west side of the property and might be willing to add another on the east side of the property until the permanent restroom facility can be built.

## Joseph Schneider, 64 Eaton Drive – Code Enforcement Procedures

J. Schnieder stated that he has spoken with Council and Borough employees regarding on-going problems with his neighbor over the past year and has seen no improvement. He stated that the current Borough ordinances need updated in order to streamline the process for complaints and corrective action. He asked Council to support P. Gehrlein in writing new ordinances to improve the Code Enforcement procedures in town. A. Belson stated that P. Gehrlein is also working with the solicitor in this matter.
