

Job Title: Laborer II

Reports to: Superintendent

Department: Wastewater

FLSA Status: Non-Exempt

***Work Objective:***

This is a semi-technical position maintaining all wastewater facilities and equipment including treatment plant components, collection system, pump-stations and ancillary equipment. Laborers perform tasks as assigned by supervisors and operators to achieve operational goals established by the wastewater department supervisors. Laborers assist with and perform treatment plant operational tasks as assigned in accordance with established practices and standard operating procedures. A Laborer II will have to go to the land fill and drive the Vacuum truck when directed by a Supervisor.

***General Duties:***

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required to achieve satisfactory performance.

- Understand and apply appropriate safety practices and measures at all times including the proper use of Personal Protective Equipment as required.
- Perform necessary Wastewater sampling and lab testing when required.
- Properly record and maintain records of operational data as required.
- Perform scheduled and unscheduled maintenance of all plant equipment, buildings, tanks, vehicles, and ancillary equipment.
- Perform all tasks associated with sludge dewatering including lining and loading trucks and transporting sludge to the landfill.
- Pre-trip inspections on Tri-axle Dump Trucks
- Take the Vacuum truck out on call outs or as directed by management.
- Perform custodial duties including cleaning all work areas, restrooms, storage areas, and pump stations.
- Perform collection system maintenance and inspections utilizing various types of equipment including: combination sewer rodder / vacuum truck, main line inspection camera, inflatable plugs, pumps and other sewer maintenance tools and equipment.
- Operate small or minor equipment including lawn mowers, tractors, chain saws, pressure washers, trash pumps, snow blowers and other equipment used by the Borough.
- Maintain all tools and equipment in proper working condition.
- Perform grounds keeping including mowing, tree trimming, weed removal as well as snow removal.
- Perform tasks associated with chemical addition processes including mixing, measuring, and moving chemicals while observing proper safety procedures.
- Operate forklift to load and unload materials and supplies as needed.
- Perform traffic flagger duties.
- Operate motor vehicles to transport personnel and equipment.
- Other duties as may be assigned by Borough management

***Certifications, Licenses, Registrations:***

- High school diploma or General Education Degree (GED) and one year experience and/or training in the essential duties outlined within this job description or a combination of experience and training
- Must possess and maintain a valid Commercial Driver's License (Class B with air brake and tanker endorsement)

***Preferred Skills or Abilities:***

- Mechanical experience
- Metal fabrication experience
- Heavy equipment operations experience
- Wastewater treatment experience
- Basic Electrical Experience

***Physical Demands:***

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of the position outlined in this job description. Employees must have the ability to perform strenuous physical duties for long periods of time in adverse weather conditions. While performing the duties of this position, the employee may be required to perform any or all of the following:

- Stand for up to eight hours
- Walk up to a half mile
- Sit or lay down
- Use hands or fingers to touch, feel, grasp, manipulate, and control equipment, tools and other objects.
- Reach with hands and arms from below the feet to above the head.
- Climb stairs and ladders.
- Balance
- Stoop, kneel, crouch, and crawl
- Dead lift up to 50 pounds
- Lift 50 pounds chest high
- Carry tools and equipment over rough terrain, up steps, or into confined spaces,
- Enter certified or permitted confined spaces using proper techniques and safety equipment and procedures

***Work Environment:***

The work environment is typical for individuals employed in Wastewater treatment facilities and wastewater collection systems. Employees frequently work with or near moving mechanical equipment and machinery. Employees are potentially exposed to high noise levels, chemical fumes, toxic and hazardous chemicals, human fecal matter, industrial waste, unpleasant odors, road traffic, various plants and vegetation, extreme temperatures, inclement weather, rough terrain, and sharp objects.

Work is performed primarily at the wastewater treatment plants. Work will also occur on Borough streets, wooded areas, near creeks and streams, or other locations inside or outside the Borough.

Daily reporting location is one of the Wastewater treatment plants unless otherwise directed.

This position requires weekend and holiday duties as well as “on call” duties.
