P. Gehrlein gave a recap of the recent DEP-issued boil advisory that occurred December 20-26, 2024. He stated that the precautionary boil advisory was implemented by the PA DEP following their inspection of the water filtration plant, during which they found several small tears on the cover of the finish water reservoir which could cause "potential contamination." He stated that repairs were made to the cover on December 23, 2024, a new cover has been purchased, the water was drained from the reservoir, and seventy (70) water samples during that time frame were all clear, showing no signs of contamination. He thanked the community for their understanding and the water department for their hard work over the holiday.
